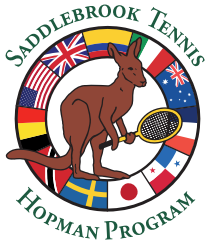

Additional charges apply if transportation is required outside the standard times of 11:00 am to 6:00 pm. Please notify us at time of booking if you would like a pro to meet your child at the gate. Only juniors recognized by the airlines as "unaccompanied minor" can be met at the gate. A \$75 meet & greet charge applies. Unaccompanied minors requiring this meet & greet service **must** arrive on a Sunday between 11:00 am and 6:00 pm, and depart on a Saturday between 9:00 am and 4:00 pm. 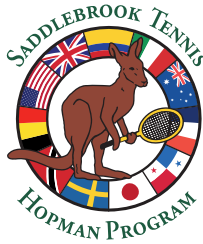

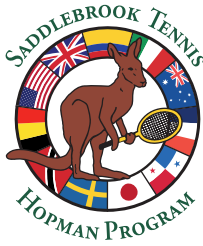

RULES & REGULATIONS FOR ALL JUNIOR TENNIS CAMPERS

WHAT TO PACK

- Racquets (*at least 2*), stinging available in the pro shop
- Tennis sneakers (*broken in, avoid running sneakers*)
- 8-10 pairs of socks
- Sunscreen and hat
- Swimsuit
- Shorts and T-shirts
- Shoes for every day
- Casual clothing for evening activities
- Airline Ticket
- \$150 per week in Cash (*can be left in Front Office safe*)
- Band-aids and tape (*for blisters*)

WHAT NOT TO PACK

Saddlebrook Resorts, Inc, or the Saddlebrook Golf Academy are not responsible for lost or stolen articles. It is **strongly recommended** leaving home expensive or unnecessary items of great value. Please mark all equipment with the camper's name. All money and valuables (airline tickets, cash, passport etc.) should be kept in the safe at the Front Office.

SPENDING MONEY

Absolutely no room charges are allowed. We recommend you send your child with a prepaid Visa/MasterCard gift card. Saddlebrook gift cards are available in \$50 increments. To order a Gift Card mark the gift card option and the desired amount on the credit card authorization form. The card can be renewed up to the amount authorized but refunds will not be issued for remaining balance on the card.

HOUSING RULES & REGULATIONS

- Any damages that may occur in a room will be charged to the occupants of the room equally unless a particular camper takes full responsibility. Rooms are to be kept neat and students using washers and dryers are reminded not to overload the machines. Housekeepers are on a schedule so please do not ask them to come back later.
- Juniors are usually assigned rooms according to age. Most roommate requests can be accommodated but under no circumstances are juniors to switch rooming assignments.
- Juniors will not be permitted to leave Saddlebrook property. Exceptions may include: Supervised camper outings, written permission from a parent.
- Juniors are not permitted to have private or rental vehicles on property. Campers are forbidden to drive golf carts at any time in accordance with Saddlebrook Resort rules.
- Bed checks will be held at 9:00 pm every evening. Each junior is expected to be in his/her room at this time. Boys will not be allowed in girls rooms at any time and vice versa.
- Any junior found in possession of alcohol, cigarettes, narcotics or weapons will be subject to investigation by Saddlebrook Security.
- Theft and/or vandalism will not be tolerated and will be turned over to Saddlebrook Security.
- Disrespectful conduct including fighting, verbal abuse, or bullying is unacceptable behavior.
- Please call to confirm your airport transportation departure assignments at least 48 hours in advance at the Transportation Desk in the lobby or by calling ext 4455.
- Pets are not allowed. Do not feed or encourage any animals (wild or otherwise) on the property.
- No loud music in rooms. Please be mindful of neighboring guests.
- Sexual harassment of any kind will not be tolerated.
- No cooking in junior rooms. All meals are to be supervised. There will be a trip to the grocery store each Sunday so campers can stock up on snacks and drinks.
- Be polite and courteous to all resort guests and employees at all times.
- Report to your location on time. You may only be absent if you are sick or injured and the camp director must be notified.
- Saddlebrook Resort reserves the right to remove a camper from the program who poses a danger or threat to other campers or is excessively disruptive to the camp as a whole.

All campers are expected to observe the above rules and regulations. Failure to follow these guidelines or endangering any persons or property will result in discipline up to and including expulsion from Saddlebrook without refund. *Additional guidelines may be distributed upon arrival.
